HOW DO I FIND/CONTACT MY LOCAL COUNTY ASSESSOR?

Click <http://cama.wyoming.gov/Lists/County%20Assessors/AllItems.aspx> find your county of residence, then click on their email address in the far right column. This website also provides phone numbers.

HOW DO I FIND/CONTACT MY LOCAL COUNTY TREASURER?

Click <http://www.wcta.us/contact.htm> find your county of residence, then click on the name of your County Treasurer to send an email. This website also provides phone and fax numbers and address's.

HOW DO I FIND/CONTACT MY LOCAL COUNTY COMMISSIONERS?

Click <http://www.wyo-wcca.org/members.htm> then click on your county of residence. This website lists the names of commissioners in each county, the county office phone and fax numbers and in some cases, a link to the county's website.

HOW DO I RESEARCH STATE STATUTES?

Go to <http://legisweb.state.wy.us/statutes/statutes.aspx?file=titles/Title39/T39CH10.htm> which takes you to the chapter that relates to property tax programs, number 13, "Ad Valorem Taxation".
