

Special Districts - Cemetery

Property Tax Levy: \$ 5,574,140

Cemetery special districts provide and maintain cemeteries and are required to keep them to a uniform standard across their district. Cities and towns in cemetery special districts are not allowed to run their own cemeteries, so the special district is the sole provider in the areas they exist. They are provided for under WS 35-8 and limited to a 3 mill levy.
